\$1,700 USD

Annual Sponsorship Renewal (Years 2-5)

\$1,000 USD

Sevis Fee

\$220 USD

Sponsorship Fee Refund: 100% pre-evaluation; 50% post-DS-2019 issuance; 0% after J-1 arrival.
I-901 Refund: 100% pre-approval; 0% post-approval. (SEVIS Fee is paid at the time of approval.)

HEALTH INSURANCE FEES

Teachers select their preferred, compliant insurance policy. They can elect to obtain medical insurance through their host school (pending AIFS review and approval) or one of the following plans offered by AIFS. *J-1 holders and their dependents enrolling in a school-sponsored plan will automatically be enrolled in the Medical Evaluation & Repatriation of Remains (MER) supplement to ensure compliance.*

MER Supplement Only

\$12 USD per month, per person

Basic Plan

\$75 USD per month

Upgraded Plan

\$105 USD per month

Dependent Family Plan – Basic

\$155 USD per month, per dependent

Dependent Family Plan – Upgraded

\$210 USD per month, per dependent

Insurance Refund: 100% before the J-1 participant arrival; Post-arrival – if cancellation 3+ months early, refunded premium of unused months; 0% if program ends less than 3 months early.

New Host School On-Boarding & Visit

\$200-\$500 USD

J-2 Dependent Sponsorship

\$700 USD/1 J-2 or \$850 USD/2+ J-2

Expedited Application Processing

\$1,200 USD

DS-2019 Amendment/ Replacement

\$100 USD

Change of Host School Fee *Change of Host would also incur new on-boarding & visit fee

\$650 USD

Extension Application Fee (Years 4/5) *In addition to annual sponsorship renewal

\$300 USD

New Host Onboarding & Site Visit, Extension, Amendments, and Change Refund: 100% before service completed; 0% after service completed.

J-2 Sponsorship Refund: 100% pre-approval; 50% post-DS-2019 issuance; 0% after J-2 arrival.

Family Plan Insurance Refund: See J-1 insurance above.

Expedited Fee Refund: 100% pre-evaluation; 0% after approval.
